:- DECLARATION OF TRUST :-

I , the undersigned Shastri Krishnaswarup Narayanswarup, Now R/O. Junagadh do hereby declare this trust that:-

I hereby declare this trust for the arrangement of my own earned and own possessed a sum of Rs. 500 /- .That neither my followers nor students have any right over the said amount. This amount is to be used for the benefit of the trust declared as under and I shall not return this amount from the trust.

As stated above , for the arrangement of my own amount , I hereby declare by this application and executed the document in detail as under:-

(1) NAME OF THE TRUST:-

The name of this trust is to be known as **"SHRI SWAMINARAYAN SEVA NIKETAN"**

(2) TERRITORIAL LIMIT:-

The territorial limit of the trust will be all over India.


(3) OFFICE OF THE TRUST:-

The office of this trust will remain at Junagadh , Gujarat State. Even for the convenience of administration of the trust , Head Office of the trust is to be kept at any place of India in future and can open its Branch Offices in any place.

(4) AIMS AND MOTIVES OF THE TRUST:-

The main aims and motives of this trust is to develop the education and culture of the peoples of the Society at large without any discord of religious ,cast ,languages ,territories , etc. and relating to those , following activities are to be adopted:-

- (i) This trust will establish the institutes like , Primary schools , Middle schools , colleges , Research Institutes , Higher Education schools , Technical and Employment Institutes , shall administrator and obtain maintenance amount as well as be helpful as required.

- (ii) Hostels for the students , Boardings , Gurukuls , Shelters for students , etc. be establishes , maintains as well as join with such institutes and be helpful as may be possible.
 - (iii) Give scholarship , loan , books , instruments , uniforms and to the required and qualified students and also be helpful economically to them.
 - (iv) Shall start book banks , library , etc . for the progress of the students and shall also publish publications relating to the education and do all the acts for the development of education.
 - (v) Shall act all the activities like Science literatures, libraries, museums , gardens ,etc. for the development and progress of the students and also be helpful in such activities as possible.
 - (vi) Shall projects the seminars , lectures , etc. for the development of subtle influence of education , spiritual developments in the people of the society at large and shall also publish magazines , pamphlets and also such types of activities as required.
 - (vii) Shall establish the hospitals for all kind of disease , laboratories , Nursing Homes, Dispensaries , Maternity Home , Aslime , Medical schools , Sanatorium Medical Colleges ,Blood Bank , Ambulance vans , etc. and also be helpful to such type of activities.
 - (viii) Shall establish the different types of Laboratories , Surgical X-ray machines , Laboratories , Medical Stores , etc. and also do such type of activities.
 - (ix) Shall construct or take on rent the buildings for the residence of the people who comes for the treatment of the ailing persons and shall also do such type of activities.
 - (x) Shall attempts to persuade the peoples of the society at large for the family planning and social benefits and shall arrange camps in that respects and also be helpful to such institutes and do all such types of activities.

- (xi) Shall be helpful to the needy persons for the medicines, grains , clothes , etc. and help economically to such needy persons and shall do such types of activities.
- (xii) shall establish Balashrams, Shelters for aged persons , shelter for orphans , shelter for weaker persons and be helpful to such institutes and shall do such type of activities.
- (xiii) Shall be helpful to the affected peoples in the famine, cyclone , earthquake , epidemics , riots , etc. and such types of natural and unnatural calamities and shall be helpful to such affected and needy peoples and in such manners .
- (xiv) Shall establish grass centers , a charitable asylum for crippled, weak or useless beasts and birds , veterinary hospitals , and also be helpful to the such institutes in their maintenance as may be possible.
- (xv) That for the fulfillment of the above aims and motives , required institutes be opened , operate and merge such other institutes , handover for administration as well as to be helpful to the institutes which are doing such activities and to do work co-operatively with such institutes , trusts or persons and to act jointly and / or to join with such institutes or to merge this trust with such trust and to lease, to given on rent, to give for use only or to handover with ownership the movable and immovable properties of this trust to such other institutes or trusts and to include such trusts having common activities and aims.

NOTE:

That at the time of interpretation of the above stated aims and motives and to interpret at large as per nationally and at the time of difference of interpretation, to interpret as per decision of the chairman of the trust.

(5) **CAPITAL:-**

The trust shall obtain income and capital for the fulfillment of the aims and motives of the trust as state in column-4 as stated under:-

- (1) Donation, Gift, Funds etc.
- (2) Conditional or unconditional donations, Gifts and Funds etc.
- (3) From the properties of the trust and Funds.
- (4) From the grants, subsidies of government and semi government
- (5) Loans and deposits

(6) **PROPERTY OF THE TRUST:**

The cash property mentioned shall be treated as the trust property and all the income from the deposits, interests, Dividends, rental income or any other income shall be considered to be the property of the trust and all such properties shall be utilized for the motives of the trust only.

(7) **SPECIAL POWERS OF TRUSTEES:**

All the trustees of this trust are empowered to decide as to what amount be expensed for the activities and motives stated in column – 4, what amount be given for which of the institute as well what property shall be used in which of the activity of the trust. The trustees have a right to fulfill the aims and motives of the trust and utilize the properties of the trust as decided by them with majority and all the trustees shall take decision with majority for purchasing the property on behalf of the trust, to obtain any of the property on rent, to develop, to exchange, to sell, to give on lease, to transfer, etc. and on account of difference which may arise in the above act, the decision of the chairman of the trust be considered as a final decision.

(8) **WELL-WISHING OF THE TRUST:**

That for deciding the well-wishing of the trust, there shall not be any bar of community, languages, religious, regions, age, etc. and the properties of this trust shall be used for all mankind a charitable asylum

for crippled, weak or useless beasts and birds, and shall utilize the same for fulfillment of all the above activities as they deem fit.

(9) TRUSTEES OF THE TRUST:

(1) Following persons are appointed as trustees for the administration of this

Trust: (1) SHASTRI KRISHNASWARUP NARAYANSWARUP

(2) PANSURIYA KISHORBHAI ARAJANBHAI

(3) SHASTRI JAYSWARUPDAS

(4) PARSOTTAM MATHUR PADSALA

(5) JALPAN KISHORBHAI PANSURIYA

(2) This trust shall consist minimum 5 and maximum 11 trustees.

(3) Shastri Krishnaswarup Narayanswarup will be the chairman trustee of this trust for the lifetime and Shastri Krishnaswarup Narayanswarup will be the Managing Trustee of this Trust of the life time. Except both these trustees, the limitations of designation of the trustee be decided by the Chairman Trustee.

(4) The Chairman Trustee shall be the final authority to appoint trustee in the trust to the person as he think fit for this trust as and when there shall be vacant post of Trustee.

(5) After the death of Chairman Trustee or under any reason if this post be vacant, then in such circumstances, Pansuriya Kishorbhai Arjanbhai will be the Chairman Trustee for his life time.

(6) As and when the post of Managing Trustee be vacant , then all the trustee shall appoint the proper trustee as a Managing Trustee of this Trust under the majority and they shall decide the period of this designation.

(10) CHANGE IN ADMINISTRATION:-

(i) That for the smooth administration of this trust, all the trustees shall frame rules and regulation from time to time if required, shall make changes in it.

- (ii) That on being required, Trustees shall appoint committees for obtaining funds, Construction committee, Administration committees, Local committees, Advisory committees, etc. amongst them or the persons from out side in the interest of trust and all these sub – committees shall be liable under the trustees.

(11) ACCOUNTING YEAR:-

The accounting year of this trust shall be commenced from the month of April to March of every year i. e. A/C. shall be ended on 31st of march of every year.


(12) ACCOUNTS:-
